In pursuant to the letter dated 22nd March 2013 a personal hearing was granted to the Institute authority to present before the Board of Governors with written submission. The Institute representatives appeared before the Board of Governors on 25th March 2013 and submitted the written submission/compliance and verbal explanation.

The Board of Governors after due consideration and scrutiny of additional documents submitted along with review of assessment report and taking into consideration verbal explanation, decided to reiterate their earlier decision and issue *Conditional Letter of Permission* for Increase of seats in MD(Paediatrics) course from 01(One) to 02(Two) seats per year,

The Board of Governors want to ensure that the quality of Medical Education is preserved for the permitted Postgraduate courses, thus the Board has permitted with reasonable number of seats for starting of the training programme and will consider further increase based on the ongoing training programme, available clinical material, faculty and facilities. The Board further wants that the Institute should indulge in academic activities including research and publications with the ongoing PG programmes.

This Letter of Permission is subject to fulfillment of the following conditions:-

1. The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings, equipment and hospital facilities as per Medical Council of India norms. I am further directed to inform that you and your institution are fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. throughout the academic year, as stipulated in Postgraduate Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring permission of the Board of Governors for the starting/increased intake and the said misconduct is brought to notice or comes to the knowledge of Medical Council of India at any stage during the current academic year, your institution is not liable to be considered for increased intake for the next academic year and this letter of permission for the increased intake/starting is also liable to be revoked for current academic year. Besides, Medical Council of India is entitled to take all such measures against you and your college/institution as permissible under the law.
2. Other deficiencies if any pointed out in the inspection report should be rectified. A copy of MCI inspection report is enclosed.
3. No student should be admitted in the above courses till the formal permission of the Board of Governors is granted.
4. The applicant should provide Bank Guarantee of required amount wherever required in favour of Secretary, Medical Council of India, New Delhi valid for three years from a nationalized/scheduled Bank as per MCI's norms against increased intake/starting of above said course. However, Bank guarantee is not applicable for Government institution.
5. The college has to give an undertaking that the students admitted to this course shall be paid stipend on par with the stipend being paid to the Postgraduate students of State Government Medical Institutes/Central Government Medical Institutions, in the State/Union Territory

6. Postgraduate students admitted to this course would be required to present one poster presentation to read one paper at a national/state conference and to present one research paper which should be published/accepted for publication/sent for publication during the period of his Postgraduate studies so as to make him eligible to appear at the Postgraduate degree examination as prescribed in the Postgraduate Medical Education Regulations notified vide Gazette Notification dated 09/12/2009 (Clause 13.9).
7. As per Postgraduate Medical Education Regulations under Clause 14.(4)(a) it has been prescribed that "Every candidate shall carry out work on an assigned research project under the guidance of a recognized Post Graduate Teacher, the result of which shall be written up and submitted in the form of a Thesis. The thesis shall be examined by a minimum of three examiners; one internal and two external examiners, who shall not be the examiners for Theory and Clinical examination. A candidate shall be allowed to appear for the Theory and Practical/Clinical examination only after the acceptance of the Thesis by the examiners."
8. The Medical college while making admission to the course shall ensure that:-
  - i. No admission is permitted beyond the sanctioned intake capacity.
  - ii. Selection of students to the Medical College is in accordance with the requirements laid down in the Postgraduate Medical Education Regulations, 2000.
  - iii. No admission is permitted beyond the cutoff date



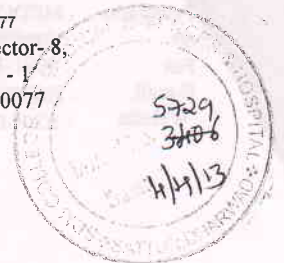

6. Postgraduate students admitted to this course would be required to present one poster presentation to read one paper at a national/state conference and to present one research paper which should be published/accepted for publication/sent for publication during the period of his Postgraduate studies so as to make him eligible to appear at the Postgraduate degree examination as prescribed in the Postgraduate Medical Education Regulations notified vide Gazette Notification dated 09/12/2009 (Clause 13.9).
7.
