Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 28/03/2014 considered Council assessor report (November, 2013) on the physical and other teaching facilities available at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka for the award of DCH qualification under Rajiv Gandhi University of Health Sciences, Bangalore. The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (November, 2013) and decided to recommend that DCH qualification for 1(one) seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at SDM College of Medical Sciences & Hospital, Dharwad, Karnataka be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Council further approved the following recommendation of the Postgraduate Committee as ammended:

"The Postgraduate Committee further decided that the attention of the institute be drawn to Sections 6 (4), 6 (5) & 6 (6) of Postgraduate Medical Education Regulations, 2000 as amended by amendment notification "Postgraduate Medical Education (Amendment) Regulations, 2009 Part-II" dt. 21/07/2009 and act appropriately at appropriate time which read as under:

6. ...

(4) The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed. further approved the following recommendation of the Postgraduate Committee as ammended:

(5) The procedure for Renewal of recognition shall be same as applicable for the Award of recognition.


(6) Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate course.....”


